The Town desires to install guardrail on SW 127th Avenue between the edge of pavement and the canal bank from Stirling Road (State Road 848) to Old Sheridan Street (approximately 5,300 linear feet total).

SW 127th Avenue connects to State Road 848 (Stirling Road). SW 127th Avenue is a two lane north/south thoroughfare in the Town of Southwest Ranches. The shoulder on this two-lane roadway narrows to approximately 24 inches from a deep drainage canal. This constricted roadway in combination with a lack of street lighting creates a hazardous condition. The close proximity of this road to the canal has led to serious injuries and tragic results on several occasions.

The intent of this project is to increase safety along this roadway and to save lives. On numerous occasions, the extreme proximity of the canal has led to serious injuries and even deaths as it is simply too easy for vehicles to run off the road and into the canal due to the lack of guardrail or other approved barrier.

**b. What activities and services will be provided to meet the intended purpose of these funds?**

Safety guardrail will be installed on SW 127th Avenue between the edge of pavement and the canal bank from Stirling Road (State Road 848) to Old Sheridan Street (approximately 5,300 linear feet total) to increase safety along this roadway and to save lives.

**c. What direct services will be provided to citizens by the appropriation project?**

Business recruitment, job creation and related economic opportunities will be enhanced for the State, and its adjacent municipalities, by providing a safer corridor. This construction project will employ nearly 40 Floridians within the next year, including all of the construction jobs, and permanent jobs in the nearby businesses.

The installation of guardrail along SW 127th Avenue will dramatically increase the safety of the thousands of motorists that traverse it each day, allowing the traveling public to conduct business with local merchants and companies that directly access this roadway.

The intent of this project is to increase safety along this roadway and to save lives. This will be measured by the number of accidents on the roadway.
