4. Project/Program Description

The Red Ribbon Certified Schools (RRCS) process will service approximately 15,000 students in North, Central and South Florida. It is an environmental change process that aligns Teachers, Parents, Students, and Administrators into a team to create an effective and healthy school climate through parental engagement and community building. RRCS is based on the research from Project Northland (Feb 2002), a well-documented evidence-based study. The certification process recognizes schools that fully embrace prevention criteria towards evidence-based, school-based prevention efforts against youth substance misuse. The goals are to provide year-round youth substance misuse prevention education, parent training and community-based prevention activities aimed at improving school climate, enhancing school-based protective factors, increasing community support, and boosting parental involvement-a key factor in academic achievement and healthy development.

14. Program Performance

a. What specific purpose or goal will be achieved by the funds requested?

RRCS will service approximately 15,000 students in North, Central and South Florida. The goals are to provide yearround youth substance misuse prevention education, parent training and community-based prevention activities aimed at improving school climate, enhancing school-based protective factors, increasing community support, and boosting parental involvement. RRCS is based on the research from Project Northland (Feb 2002), a well-documented and evidence-based study. In 2008, DCF nominated RRCS as a Service to Science project with SAMSHA and RRCS received an evidence-based certification from SAMHSA in 2013.

b. What activities and services will be provided to meet the intended purpose of these funds?

The RRCS process will provide 4 year-round prevention campaigns to engage parents, teachers, students, school administrators and communities in creating healthy behavioral change measured by improving the School Climate Survey results. The four programs include: Family Day (Sept), Red Ribbon (Oct), Lock Your Meds (Jan), Safe Homes Smart Parties (May). These educational campaigns promote engagement and youth substance misuse prevention.

c. What direct services will be provided to citizens by the appropriation project?

RRCS will provide hands-on direct services in support of parents, teachers, administrators, and students to form a team that creates a strong school community. The certification services will supply resources impacting approximately 15,000 students across Florida in 3 areas: 1) Mentors to support schools through the certification process, 2) Events and materials highlighting the dangers of substance misuse, and 3) Science-based educational workshops for parents and students towards improving their school climate and learning environment.

d. Who is the target population served by this project? How many individuals are expected to be served?

RRCS will impact approximately 15,000 students statewide across North, Central, and South Florida. The initiative targets parents, teachers, administrators, students, and employees within a school. The objective is to build a strong and effective school community focused on improving school climate and protective factors. Miami-Dade County and Orange County Coalition Community Action Plans show a need for consistently delivered and integrated community education strategies regarding alcohol and other drugs. RRCS is supported by the Governor's Drug Policy Council Report of 2022 to deliver needed integrated community education strategies, while creating stronger community engagement in youth substance misuse prevention.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will

be measured?

The RRCS process is focused on improving school engagement, safety and the environment within schools by 10% as measured by the Dept. of Education School Climate Survey (EDSCLS). School teams will complete the RRCS application form, which will be evaluated by the University of Central FL Department of Research and Development. Schools that score 80 points or higher will be become a Red Ribbon Certified School. A primary goal of RRCS is to reduce substance misuse in youth. Published research about the RRCS process in the Journal of Global Drug Policy and Practice showed a 50% decrease in positive attitudes and frequency for alcohol and marijuana use vs a control group of non-certified schools.
